All-State Accompanist/Jazz Band Rhythm Section Coach Contract and Agreement

This Contract and Agreement is between the Idaho Music Educators Association (IMEA) and a qualified Guest All-State Group Accompanist or Jazz Band Rhythm Section Coach. Both parties, IMEA and the guest accompanist/coach agree to the following:

1. _____ agrees to serve as Accompanist/Rhythm Section Coach of the _____. This includes preparing and accompanying all scheduled rehearsals and performances on _____ at _____.
2. IMEA agrees to pay a fee of \$_____.
3. IMEA agrees to provide *either* housing or mileage.
4. IMEA will not reimburse the accompanist/coach for any other travel expenses.
5. IMEA will not reimburse for meals not provided during the event. Accompanists/Coach will be included in the lunches provided for the All-State Conductors and group chairs and the evening banquet.
6. Both Parties (Guest Accompanist/Coach and IMEA) agree to save harmless the other party in case of a catastrophic situation which causes IMEA to cancel the All-State Music Ensembles. A "catastrophic situation," shall include, but not be limited to, an act of God, act of nature (including any epidemic or outbreak of pandemic disease), storm, flood earthquake, fire, act of government or state, war, civil commotion, insurrection, embargo, labor dispute, and any other situation or event out of the reasonable control of the Parties.
7. Both Parties (Guest Accompanist/Coach and IMEA) agree to save harmless the other party in case they are unable to serve because of illness or accident. IMEA will have the right to appoint a substitute to carry out the duties outlined.
8. In the event of the cancellation of this agreement, the party so cancelling shall notify the other party at the earliest possible date prior to the event date. Proper cancellation by mutual agreement relieves the other party of all obligations. THIS CONTRACT IS NOT VALID WITHOUT ALL SIGNATURES.
